Take precautionary measures against static discharges. Take up mechanically and collect in suitable container for disposal. Keep in suitable and closed containers for disposal. Use personal protective equipment. Do not dry sweep dust. Wet dust with water before sweeping or use a vacuum to collect dust.

Methods for cleaning up.

Use personal protective equipment. Cover powder spill with plastic sheet or tarp to minimize spreading and keep powder dry. Take up mechanically and collect in suitable container for disposal. Avoid dust formation. Clean contaminated surface thoroughly.
